

From the Desk of Mayor Coleman

A Look Ahead to 2012

As we look forward to 2012, let me first say how proud I am to have the opportunity to serve as your mayor for the next four years. I am also very excited to work with our newly elected city council. Cathy Murphy was unanimously elected council president by the other council members. This is a role with which she is very familiar. She has two years of previous experience servicing as council president. In addition to running the council meetings and planning the agendas, the council president needs to choose the committee assignments for the other members of council. The committee assignments were announced at our first meeting on January 3rd and are listed on our website at www.highlandhts.com. Chuck Brunello was sworn in as a new member of city council. Chuck has been very active in our city, having served as Community Day chairman for the past two years. Chuck also had previously served on our Park and Recreation Committee

At this first meeting, I had the opportunity to make my appointments to various committees as well as my department heads. Most of the committee appointments remained the same; however we do have four new members to committees. I am pleased to announce that Jolene Greve and Frank DiLalla were appointed to the Park and Recreation Committee. Both Jolene and Frank have been very active in our community and will bring an enormous amount of energy and enthusiasm to our park programs. Delores Hrvatin was appointed to the Commission on Aging. Delores' husband Ray served for many years on the commission. Delores has been very active volunteering on this committee for the past several years. David Melito was appointed to the Tax Incentive Review and CRA Housing Council. David brings a wealth of knowledge about finances and taxation to this committee that oversees the incentives we offer to businesses in our community.

Budget and Finances

Our financial position in 2011 was very encouraging. We saw our General Fund revenues increased by over 8%, with income tax collections remaining strong. We are fortunate to have a diverse yet seemingly stable employer base which contributed heavily to our strong collections last year. Our overall income increased 7% in 2011. We were also able to contain costs. Although our General Fund expenditures rose, the 3% increase allowed us to accommodate and maintain our high level of service to the community. Overall, our fund balances grew by 19%, which positions us comfortably into 2012.

Probably the most important order of business in the first few months of the year is to establish a budget. I am proud to say that I have presented to council a budget that is balanced. This has become very difficult in light of the fact that all municipalities are dealing with the loss of several sources of revenues from the state. Still in the early stages, the 2012 budget promises to be challenging. We will continue to be prudent in budgeting for all departments.

From the Desk of Mayor Coleman

In addition to the many improvements made last year, the 2012 budget will also incorporate additional projects. We will be purchasing a new rescue squad allowing our paramedics to perform their vital roles more efficiently. We will also be replacing needed equipment in our Service and Police Departments. And of course, we will be repairing and resurfacing a number of streets throughout the community. We are planning on improving the roadway at the municipal park as well as adding a much needed pavilion to keep our day campers safe. Additionally, the park should see added improvements to the bathrooms in the pool house and the installation of home run fences at many of the ball fields.

The City was fortunate to obtain a grant for improving the lighting in and around the municipal complex. That project has already been approved by Council and will begin shortly. We are taking a close look at resurfacing the entire lot including driveways at City Hall. This project could involve the installation of permeable pavement which is designed to allow rainwater to drain downward between interlocking concrete pavers, minimizing excessive storm water runoff. We are also looking forward to further improvements to the lot adjacent to the Police Department which saw a gazebo go up last year. These improvements should entail electrical and water service and landscaping.

I will miss Diana and the extraordinary support she has given me over the past eight years. Diana was hired by my predecessor, Mayor Hogg and has proudly served the residents of Highland Heights for the past 13 years. Jefferson Influx and Infiltration Update

Since I last wrote about this issue almost 2 years ago, much has happened in our Cleveland and much has remained the same. We have a new form of county government, a local basketball player took "his talents" south, a new casino is about to open in Cleveland, and none of our professional sports teams have brought home a championship.

This project was originally slated to be done during the winter of 2010-2011. The County budgeted around \$750K for project completion. Unfortunately quotes came in twice the estimated budget based on the scope of work laid out in the bid contract. Needless to say, the backhoes never got out of the barn.

This past summer the project scope was reviewed and downsized in order to bring the project cost down. When the new numbers finally came in, the winning bid was \$360K or around half the original budget. When questioned on how that number could be so low compared to prior bid, it was said that company with the winning bid will be able to line the sewer line, robotically, thus eliminating most of the excavation and cost that would have been required by going house to house.

Liqui-Force, a Michigan based company, was awarded the contract and should begin work in March with minimum disturbance of individual properties. One snag came up during final contract negotiations and was resolved. No University of Michigan paraphernalia can be worn on the job. Concurrently, the County will begin dye testing sewers on Sturbridge to identify any problems with storm runoff infiltrating the sanitary sewer, causing flooding problems for residents downstream. Eventually, all the streets in the Williamsburg development will have their sewers checked. We will keep you informed as we get more information on the testing program.

HOUSEHOLD HAZARDOUS WASTE ROUND-UP (APRIL 2ND - APRIL 14TH) (JULY 30TH -AUGUST 11) (NOV 26TH - DEC 1ST)

The city will once again be conducting a household hazardous waste collection program in cooperation with the Cuyahoga County Solid Waste District. Residents wishing to participate in the program may bring unwanted pesticides, household chemicals, and oil based paints to the Service Department between the hours of 8:00 a.m. and 3:30 p.m. Monday through Friday and on Saturdays from 9:00 am to 1:00 pm during any of the scheduled dates listed. Latex paint will not be accepted. Latex paint is not considered hazardous waste. It should be dried and disposed of in a solid state. For information on drying latex paint, please contact the Service Department or visit our web site.

COMPUTER ROUND UP (April)

The City will once again be partnering with the Cuyahoga County Solid Waste District to recycle computers, monitors, keyboard and cell phones during *Recycle your Computer Month*, which will take place throughout the month of August. Residents wishing to participate in the program can drop off items at the Service Department between 8:00 am and 3:30 pm Monday through Friday during the month of April. The Service department will package the items for delivery to the county for proper recycling and disposal.



BRUSH COLLECTION (April 2nd - June 15th)

The Service Department will be conducting a spring brush collection from April 2nd through June 15th. Residents are asked to observe the following guidelines: Collections will be made Monday through Friday between 8:00 am. and 4:00 pm. Residents are asked to contact the Service Department at 461-7266 in advance to schedule a pick up. Branches can be of any length and need not be bundled, however, because the material will be loaded by hand, and due to equipment limitations, the size of the branches accepted will be limited to a maximum of 6" in diameter. Residents will be responsible for getting material to the tree lawn prior to collection.

Beyond the program, brush may be tied and bundled in four foot length for collection by our rubbish contractor year round or, by special arrangements with the Service Department as time allows. Please contact the Service Department for more information.

SEWER REPAIRS ON JEFFERSON DR. - UPDATE

The Cuyahoga County Department of Public Works, Division of Sanitary Engineers has announced that the redesigned sewer rehabilitation project on Jefferson Drive has been awarded and will soon be under way. The project will involve the lining of sanitary and storm sewer laterals in the right of way. In most cases the work will be completed in the right of way with minimal property disturbance.

The repairs being made are intended to reduce the inflow of storm water into the sanitary sewer system there-by reducing the frequency and severity of basement flooding to downstream homes.

The County anticipates that work will begin in late February or March. Jefferson Drive residents will be receiving additional information as details develop.

BUILDING DEPARTMENT DALE GRABFELDER, BUILDING COMMISSIONER

This has certainly been a winter to remember, rain, snow, and then back to rain. The building department has received a large amount of calls concerning drainage problems. Some of these problems were caused by the over saturation of the ground, due to so much rain. A few things that you the homeowner can do is:

Keep all swales clean of leaves and debris. Make sure that if you have a catch basin in your rear yard that it's kept clean and free of all debris. Look at any yard landscaping. It may be that your landscaper has built up your flower beds and they may be obstructing the flow of water.

A reminder, you just can't change your property grade, or add a drainage system without permits. The Building Department, along with the Engineers Office, needs to see plans to assure that the system is installed properly. Even though it's been raining, it also has snowed.

Please make sure your snow plow operator has registered with the police department. Also remind them that snow needs to be plowed onto your own property. Please do not block sidewalks or plow into the streets. This poses safety issues not only for residents but also for our service personnel who work to remove the snow from our streets and sidewalks.



I am pleased to advise residents that council is in the process of adopting a new ordinance on rain barrels. So before you place a rain barrel in your yard, please call the building department so we can advise you of the placement under the new ordinance.

Burglary Prevention Tips

In 2010, there were over two million home burglaries in the United States. Most of the break-ins were residential and preventable. In 2011, there were 14 reported residential and commercial burglaries in Highland Heights. This figure was up from the 12 reported burglaries the previous year. This is why we would again like to emphasize the following information to residents and business owners on how you can prevent a burglary. Burglaries have taken place in random areas and neighborhoods throughout the City, but most break-ins have taken place during the day while residents are not at home. Due to the slight increase in reported break-ins, our Department is issuing the following tips to residents and business owners to safeguard your home and property.

- We are asking that residents <u>immediately</u> report any suspicious activity, persons or vehicles in the community to the Highland Heights Police Department.
- Be a good neighbor, watch out for each other. If your neighbor is not home and you notice a vehicle or person walking around their property, call the Police Department.
- If you discover your home broken into, DO NOT ENTER call the Police immediately from a safe location like a neighbor's house or cell phone.
- If you discover your home is broken into, provide the Police Department with an itemized list of any stolen property, including any identifying marks. Avoid handling any additional property you find that may have fingerprints on it, including papers.

Residential burglaries (break-ins) are usually a crime of opportunity. Residents must be vigilant in protecting their homes. Do not become complacent. Conduct a check of your home and if you have one, activate your alarm system before retiring for the evening.

- Keep all doors and windows in your residence secured and locked. Make sure external doors have well-installed dead bolt locks. Sliding glass doors can be secured by installing commercially available locks. Activate your alarm system during the daytime hours when not at your residence.
- Keep the exterior of your home well lit. Install outside lights and keep them on at night. Create the illusion that you are home by using timers that will turn lights on and off in different areas of your house throughout the evening.
- Call regarding the Police Department's Residential Security Program. This is a free service provided by a crime prevention officer to assist residents in protecting their homes from intrusion.
- Call regarding the Police Department's Alarm Board Monitoring Program. This service is provided for residents and business who wish to have their alarm system directly monitored by the Police Department.

Protect Your Vehicle

- Always lock your car, even when parked in your driveway.
- Never leave your keys hidden in the auto--they can be found.
- Don't leave your purse or valuables in your car.
- Park in lighted areas and avoid parking in public lots for long periods of time.
- Properly used, an alarm system may prove an effective auto theft deterrent.
- Keep your garage locked and your car locked when it is parked at home.
- Don't leave the vehicle's title, credit cards, or checkbook in the glove box.

If you observe suspicious activity or person(s) around a vehicle, <u>call the police immediately</u> to report the location, description of vehicle, activity and person(s), and any other information for the police to investigate.

Landscaping Contractors Permits Required

Permits are required for any person, firm or corporation conducting landscaping services in the City. Prior to the issuance of a permit, the applicant must furnish the make, model and serial number of any vehicles to be used, along with the name, address and telephone number of the owner and operator of such vehicles. Each applicant shall pay the sum of twenty-five dollars (\$25.00) for each permit which is in effect from January 1 to December 31 of each year. Prior to the issuing of any permit, each applicant is required to furnish proof of insurance. Appli-

Both physical and classroom training is similar to that which FBI agents receive. As a graduate, Det. Sgt. Matejcic joins Chief James Cook as an alumni of the FBI Academy.

FIRE DEPARTMENT WILLIAM TURNER, FIRE CHIEF

In January, the Fire Department received a new 2012 ambulance. The manufacturer, Horton Ambulance, was chosen based on safety features, ease of maintenance and overall functionality. This state of the art vehicle will allow Fire Department personnel to continue to provide our residents with superior pre-hospital care. The new Rescue Squad is expected to last 14 - 15 years.



Open Burning

Every spring, the Fire Department receives calls regarding open burning in the City. State and Local Codes define the types of fires allowed and the requirements for these fires. Homeowners are allowed to have outdoor fires without prior notification to the Fire Department for recreational fires. Recreational fires are defined as outdoor fires utilized to cook food for human consumption and use of approved outdoor fireplaces.



It is important to note that there are several exceptions to this rule. No person, lease holder, tenant, occupant or entity shall kindle or maintain a fire for the preparation of food or for any other purpose in any type of outdoor or portable grill, whether gas, charcoal or electric, upon any balcony, under any balcony/overhang, or within fifteen feet of any multi-family dwelling or business.

In addition, the homeowner may be ordered to extinguish the fire if the fire is deemed to be a nuisance by the Fire Department or if the fire is offensive or objectionable because of smoke or odor emissions or when atmospheric conditions or local circumstances make such fire hazardous.

The Fire Department will be offering a CPR / AED class. The Class will be held at the Fire Station 5827 Highland Road on Saturday, March 31, 2012 from 10:00 a.m. until 12:00 p.m. Class size is limited to 15 students. Student manuals are available prior to the class if desired. Please contact the Fire Department at 442-7406 to sign up.



Fire Department Hydrant Maintenance

Semi-Annual fire hydrant maintenance will be conducted by the Fire Department during the months of May and June. If your water is discolored, run your cold tap water until it clears. If your laundry becomes stained, please contact the Fire Department. We can provide materials for removing the stain. Any hydrant found to be non-functional is replaced by Cleveland Water. After a hydrant is replaced, the soil around the hydrant needs to settle for several weeks prior to finish grading. Once settling has occurred, Cleveland Water or a sub-contractor will make the final repairs to the lawn. This process can take several weeks or longer to complete.



With Spring just around the corner, here are some Weather Facts from the Federal Emergency Management Agency

Facts About Thunderstorms

- They may occur singly, in clusters, or in lines.
- Some of the most severe occur when a single thunderstorm affects one location for an extended time.
- Thunderstorms typically produce heavy rain for a brief period, anywhere from 30 minutes to an hour.
- Warm, humid conditions are highly favorable for thunderstorm development.

About 10 percent of thunderstorms are classified as severe—one that produces hail at least three-quarters of an inch in diameter, has winds of 58 miles per hour or higher, or produces a tornado.

Facts About Tornadoes

Tornadoes are nature's most violent storms. Spawned from powerful thunderstorms, tornadoes can cause fatalities and devastate a neighborhood in seconds. A tornado appears as a rotating, funnel-shaped cloud that extends from a thunderstorm to the ground with whirling winds that can reach 300 miles per hour. Damage paths can be in excess of one mile wide and 50 miles long. Every state is at some risk from this hazard. Some tornadoes are clearly visible, while rain or nearby low-hanging clouds obscure others. Occasionally, tornadoes develop so rapidly that little, if any, advance warning is possible. The following are facts about tornadoes:

- They may strike quickly, with little or no warning.
- They may appear nearly transparent until dust and debris are picked up or a cloud forms in the funnel.
- The average tornado moves Southwest to Northeast, but tornadoes have been known to move in any direction.
- The average forward speed of a tornado is 30 MPH, but may vary from stationary to 70 MPH.
- Tornadoes can accompany tropical storms and hurricanes as they move onto land.
- Waterspouts are tornadoes that form over water.
- Tornadoes are most frequently reported east of the Rocky Mountains during spring and summer months.
- Peak tornado season in the southern states is March through May; in the northern states, it is late spring through early summer.
- Tornadoes are most likely to occur between 3 p.m. and 9 p.m., but can occur at any time. If you are under a tornado WARNING, seek shelter immediately!

If you are in:	Then:
A structure (e.g. residence, small building, school, nursing home, hospital, factory, shopping center, high-rise building)	Go to a pre-designated shelter area such as a safe room, basement, storm cellar, or the lowest building level. If there is no basement, go to the center of an interior room on the lowest level (closet, interior hallway) away from corners, windows, doors, and outside walls. Put as many walls as possible between you and the outside. Get under a sturdy table and use your arms to protect your head and neck. Do not open windows.
A vehicle, trailer, or mobile home	Get out immediately and go to the lowest floor of a sturdy, nearby building or a storm shelter. Mobile homes, even if tied down, offer little protection from tornadoes.
The outside with no shelter	Lie flat in a nearby ditch or depression and cover your head with your hands. Be aware of the potential for flooding. Do not get under an overpass or bridge. You are safer in a low, flat location. Never try to outrun a tornado in urban or congested areas in a car or truck. Instead, leave the vehicle immediately for safe shelter. Watch out for flying debris. Flying debris from tornadoes causes most fatalities and injuries.

Miscellaneous Updates

Cuyahoga Soil & Water Conservation District

Illegal Dumping is the improper disposal of waste at any location other than a permitted landfill or facility. Illegal dumping poses a threat to human health and the environment. Also known as open dumping or midnight dumping, illegal dumping usually happens in open areas, along roadsides, in wooded areas, streams and rivers, and frequently occurs late at night to avoid detection. The waste is dumped to avoid disposal fees or time and effort required for proper disposal. It is illegal to allow open dumping on your property. Property owners sometimes try to benefit financially by charging a fee for someone to dump waste on their property. This is illegal.

What types of materials are commonly dumped?

Construction and demolition debris like drywall, shingles, lumber, bricks, concrete and siding, large appliances and furniture, household garbage, medical waste, abandoned vehicles, parts and tires yard waste or plant materials.

Why is illegal dumping a problem?

The human health risks associated with illegal dumping are significant. Illegal dumps can be accessible to people who could come in contact with chemicals (fluids or dust) or get hurt from nails and sharp edges of materials. Illegal dumps also attract rodents and insects. For example, illegally dumped waste tires provide an ideal place for mosquitoes to breed. Mosquitoes multiply 100 times faster than normal in the warm, stagnant water collecting in waste tires. Dumps also result in a decrease in property values.

Illegal dumping can impact proper drainage making areas more susceptible to flooding when debris blocks creeks, culverts and drainage basins.

What can I do?

- If you see illegal dumping or an open dump, call your community and report it they can direct you to the proper authority.
- If you are having a house built or remodeled, make sure the waste from your site is being properly disposed of - ask your contractor for the details.
- Recvcle
- Grasscycle (leave grass clippings on lawn when mowing)
- Compost your yard waste or plant materials
- Properly dispose of solid waste

DID YOU KNOW about the Mayfield City Schools first CHEMICAL ROUND-UP in 2006?

In 2006 Mayfield City School District began to look closely at the chemicals used in various departments throughout the school district. The focus quickly turned to the number of outdated chemicals used in the science labs as well as the amount and variety of aerosol type cleaning products and pesticides. Collaboration between the Science Department Chair and the Supervisor of Buildings and Grounds led to the first Mayfield Chemical Round-up. A third party company was hired to inventory and remove all the non-essential science lab chemicals as well as all the aerosols, paints, outdated cleaning products and pesticides from the school district. Today Mayfield City Schools continues to monitor the amount and type of chemicals brought into the school system and 2007 was awarded the EPA's Tool for Schools Indoor Air Quality Excellence Award. We are proud of our contribution not only to the safety and health of our school children and staff but also our contribution to the environment as a whole.
