

From the Desk of Mayor Coleman

2011 Financial Report and Budget

I'm pleased to report that the City ended 2010 on solid financial ground. The General Fund, which drives most City operations, has a balance of \$5,200,000, an increase of \$983,000. Our Park and Recreation Fund increased its fund balance by \$127,000 to finish the year at \$304,000. Overall, the City's total fund balances grew by \$1,236,000.

We have in the past and continue to keep our expenses in check. Our General Fund expenditures increased less than 1% in 2010 over 2009. We are also fortunate to have had a strong revenue flow in 2010 which helped contribute to our financial stability.

While our 2011 budget will present some challenges, I will present council with a budget that projects our revenues to exceed our expenses. I am dedicated to structuring the budget in a manner that will continue to provide the efficient and effective use of our dollars to provide the uninterrupted, excellent delivery of services we all enjoy.

Charter Review Committee

Every five years, the mayor is to appoint a committee of nine residents to serve on the Charter Review Committee. The purpose of this committee is to review and recommend to Council not less than ninety (90) days prior to the next November election, any alterations, revisions, and amendments to our Charter as in its judgment seem advisable. Any recommendations from this committee must be submitted without alteration, to the voters at the next regular November election. The members of this committee are volunteers and serve without compensation.

Mayfield Schools

Congratulations to Mayfield Schools for receiving the ranking of Excellent With Distinction on the Ohio Report Card for two consecutive years. Congratulations also to Millridge Elementary School. They are celebrating 50 years of being part of our community.

Residents added to 100 Year Flood Zone

As a result, mortgage companies have required these residents to take out costly flood insurance. This was the result of The Federal Emergency Management Agency (FEMA) updating their flood maps. City Council and I have been working to see what, if any, assistance we can offer residents. Our Building Commissioner and City Engineer have more information on this topic.

Finance Committee, Budget Update

For the third year in a row, the City had a surplus in the completed 2010 budget. On the revenue side, the property tax was approximately 4% above budget and total income was up approximately 9% above budget. Total expenditures were approximately 2% below budget. The total budget surplus for 2010 was approximately \$1.2 million. This may seem like a lot of money but we still have millions of dollars of infrastructure projects that have been deferred.

The Budget Committee is currently preparing the 2011 budget. The revenue estimate is 4% less than last year's and the expenditure estimate is 7% above last year's. This would yield a deficit in the \$600,000 range. To further complicate the issue is the potential of the elimination of Estate Tax and/or the state subsidy to cities. This could cost us another \$500,000. At this time, these are not firm numbers and will be changed by the time the budget is finalized.

Influx and Infiltration Update

Earlier this year a new County Executive and County Council was sworn into office to govern Cuyahoga County. Goals of improving government efficiency and accountability seemed to be on the lips of all. Now you may be asking, "How does this affect me?" Residents of Jefferson Drive may have thought that they took their new promise to heart and completed the planned sanitary and storm sewer work planned for this winter without any disturbance to yards or service. Unfortunately, that was not the case.

As previously reported, the Jefferson Drive sewer project was sent out to bid late last summer. At the time, the project was estimated to cost around \$750K and would be completed over this past winter. I am sure the Highland Road residents that experience basement flooding were counting the days until this was completed and basement flooding during heavy rain storms would be a thing of the past. When the bids were opened, the county engineers were stunned to find that not only was the project not going to cost the \$750K they estimated, but in fact would cost double that amount. Needless to say, the project was not awarded.

So where does that leave us today? The project is not dead but the engineers have gone back to the drawing board. In the meantime, the county has reapplied for a loan for the project from the EPA to cover the higher costs. The county engineers are also looking at their project options in order to better rein in costs. In conversations with our city engineer, Brian Mader, he does not think that anything will happen for at least a year. So much for speed and efficiency. On a serious note, the project is still high priority and will eventually come to fruition. Stay tuned. As additional information becomes available, you will be kept fully informed.

Regional Income Tax Agency (RITA)



With the tax filing deadline quickly approaching, there may be some questions regarding municipal income taxes.

We utilize the services of the Regional Income Tax Agency (RITA) to act as our Income Tax Department. RITA provides services to over 100 communities in the area in the collection of municipal income taxes. All residents earning a wage are required to file a return with the Regional Income Tax Agency. If you use a short form which allows RITA to calculate your liability or refund, the return is due no later than March 31st. All other filers must have their returns in by April 18th. It is important to note that this requirement applies even if you do not owe any tax at year end.

You may also access the RITA website 24 hours a day, 7 days a week, at www.ritaohio.com to e-file your return online free of charge, download forms, and research frequently asked questions. You can also download the Auto Calculate Form 37 (requires Excel) to complete your return and mail it in. If you use the Auto Calculate form 37, please be sure to review the instructions before starting.

Basically, the City of Highland Heights authorizes a municipal income tax at a rate of 2% on all salaries, wages and other compensation earned by residents of the City or non-residents working in the City. Net profits earned by local businesses are also subject to our tax provisions. Residents enjoy a 100% tax credit for taxes paid to another municipality, so employment taxes paid to your work city will be used as a direct offset to your liability in Highland Heights up to 2%.

For example, if you work in Cleveland, where a tax rate of 2% also applies, the taxes withheld from your wages there would be credited to the 2% liability in Highland Heights resulting in no tax due. This applies to all localities where the tax rate is 2% or greater. If however, you should work in a city where the tax rate is 1.5%, you would owe the City of Highland Heights .50% after credit is given for your workplace wages.

If you do owe tax, you are required to make estimated payments throughout the course of the year. 80% of your estimate must be paid by January 31st of the following year, that is, 80% of your 2010 tax liability should have been paid by January 31, 2011. Billing reminders are sent by RITA to those affected taxpayers. You may also remit payments directly to RITA should your individual circumstances change.

CPR/AED CLASS

FREE SMOKE ALARMS FOR SENIORS



The Fire Department will install free smoke detectors for seniors in their residence while supplies last. The exact number that will be installed will be determined by the current code. For more information, and to verify eligibility, please contact the Fire Prevention Officer at (440) 442-7406. There is no charge to the seniors for either the smoke alarm or the service. Supplies are limited so please call soon.

OPEN BURNING

Every spring, the Fire Department receives calls regarding open burning in the City.

Both the Codified Ordinances of the City of Highland Heights and the State Fire Code address this issue. City Ordinance 1501.16 and Sections 307 and 308 of the Ohio Fire Code define the types of fires allowed and the requirements for these fires.

The City does allow homeowners to burn without prior notification to the Fire Department for recreational fires. Recreational fires are defined as outdoor fires utilized to cook food for human consumption and outdoor fireplaces.

It is important to note that there are several exceptions to this rule. No person, lease holder, tenant, occupant or entity shall kindle or maintain a fire for the preparation of food or for any other purpose in any type of outdoor or portable grill, whether gas, charcoal or electric, upon any balcony, under any balcony/ overhang, or within fifteen feet of any multi-family dwelling or business.

The homeowner may be ordered to extinguish the fire if the fire is deemed to be a nuisance by the Fire Department or if the fire is offensive or objectionable because of smoke or odor emissions or when atmospheric conditions or local circumstances make such fire hazardous.

Fire Department Hydrant Maintenance

Semi-Annual fire hydrant maintenance will be conducted by the Fire Department during the months of May and June. If your water is discolored, run your cold tap water until it clears. If your laundry becomes stained, please contact the Fire Department. We can provide materials for removing the stain.

Any hydrant found to be non-functional is replaced by Cleveland Water. After a hydrant is replaced, the soil around the hydrant needs to settle for several weeks prior to finish grading. Once settling has occurred, Cleveland Water or a sub-contractor will make the final repairs to the lawn.

BRUSH COLLECTION April 4th - June 10th

The Service Department will be conducting a spring brush collection from April 4th through June 10th. Collections will be made Monday through Friday between 8:00 a.m. and 4:00 p.m. Residents are asked to contact the Service Department at 461-7266 in advance to schedule a pick up. Branches can be of any length and need not be bundled, however, because the material will be loaded by hand, and due to equipment

limitations, the size of the branches accepted will be limited to a maximum of 6" in diameter. Residents will be responsible for getting material to the tree lawn prior to collection. Please contact the Service Department for more information.

COMPUTER ROUND UP (April)

The City will once again be partnering with the Cuyahoga County Solid Waste District to recycle computers, monitors, keyboard and cell phones during *Recycle your Computer Month*, which will take place throughout the month of August. Residents wishing to participate in the program can drop off items at the Service Department between 8:00 a.m. and 3:30 p.m. Monday through Friday during the month of April.

HOUSEHOLD HAZARDOUS WASTE ROUND-UP (SATURDAY APRIL 2ND) (MAY 2ND - MAY 14TH)

The city will once again be conducting a household hazardous waste collection program in cooperation with the Cuyahoga County Solid Waste District. Residents wishing to participate in the program may bring unwanted pesticides, household chemicals, and oil based paints to the Service Department between the hours of 8:00 a.m. and 3:30 p.m. Monday through Friday, starting Monday May 2nd and ending on Friday May 13th. We will also have two Saturday drop offs on April 2nd (in conjunction with Shredding Day) and on May 14th from 9:00 a.m. to 1:00 p.m. Latex paint will not be accepted.

Latex paint is not considered hazardous waste. It should be dried and disposed of in a solid state. For information on drying latex paint, please contact the Service Department or visit our web site.

SEWER REPAIRS ON JEFFERSON DRIVE DELAYED

Residents on Jefferson Drive as well as those in effected areas downstream, anticipating the start of a sewer rehabilitation project will be interested in knowing that the project has been put on hold. The Cuyahoga County Sanitary Engineers Office, the agency planning the work, has announced that due to higher than expected pricing received, all bids for the proposed project were rejected. The project, as planned, was to include the lining of sanitary and storm sewer laterals, and the storm sewer main.

The county is reviewing the project design and scope in order to evaluate and consider any cost savings for inclusion into a re-designed project. We are hopeful that a modified project will get underway this year.

MULCHING

Why Mulch?

Mulch has gained wide popularity in urban landscapes, both as a protective and ornamental feature. A layer of organic mulch around the trunk of a tree can be extremely beneficial. Mulching urban trees is recommended because it helps retain soil moisture, helps reduce weeds and controls grass, increases soil fertility when mulch decomposes, improves appearance, protects the trunk from injuries caused by mowing equipment and trimmers that often result in serious damage or death to trees and improves soil structure (better aeration, temperature and moisture conditions).

Common Mulching Mistakes

Two common mistakes in mulch distribution are applying material too thick or deep and mounding up mulch on plant stems. Effects of too much mulch in planting areas include excessive moisture, reduced oxygen and fungal growth. Stem girdling roots are also likely to develop. Mulch only needs to be applied and maintained at a two (2) inch depth at the trees' dripline. As the original mulch decomposes, it should be stirred, turned over or broken up to improve aeration and water diffusion capability. Mulch beds may need to be redressed with another inch of mulch every year or two in order to maintain their protective and ornamental functions.

When mulching, remember:

- Do not apply more than 3 inches of mulch
- Do not pile mulch against the trunk of a tree
- Do not let matted and compressed mulch build up year after year

Burglary Prevention Tips

In 2009, there were an estimated two million home burglaries in the United States. Most of these breakins were preventable. In 2010, there were 12 reported residential and commercial burglaries in Highland Heights. This figure was up from 5 reported burglaries the previous year. The following information is provided to inform residents and business owners how they might prevent a burglary.

Burglaries have taken place in random areas and neighborhoods throughout the City, but most break-ins have taken place during the day while residents are not at home. Due to the slight increase in reported break-ins, our Department is issuing the following tips to residents and business owners to safeguard your home and property.

We are asking that residents <u>immediately</u> report any suspicious activity, persons or vehicles in the community to the Highland Heights Police Department.

Be a good neighbor, watch out for each other. If your neighbor is not home and you notice a vehicle or person walking around their property, call the Police Department.

If you discover your home broken into, DO NOT ENTER - call the Police immediately from a safe location like a neighbor's house or cell phone.

If you discover your home is broken into, provide the Police Department with an itemized list of any stolen property, including any identifying marks. Avoid handling any additional property you find that may have fingerprints on it, including papers.

Additional Tips for Preventing Burglaries

- Residential burglaries (break-ins) are usually a crime of opportunity. Residents must be vigilant in protecting their homes. Do not become complacent. Conduct a check of your home and if you have one, activate your alarm system before retiring for the evening.
- Keep all doors and windows in your residence secured and locked. Make sure external doors have well-installed dead bolt locks. Sliding glass doors can be secured by installing commercially available locks. Activate your alarm system during the daytime hours when not at your residence.
- Keep the exterior of your home well lit. Install outside lights and keep them on at night. Create the illusion that you are home by using timers that will turn lights on and off in different areas of your house throughout the evening.
- Call regarding the Police Department's Residential Security Program. This is a free service provided by a crime prevention officer to assist residents in protecting their homes from intrusion.
- Call regarding the Police Department's Alarm Board Monitoring Program. This service is provided for residents and businesses who wish to have their alarm system directly monitored by the Police Department.

Protecting Your Vehicle

- Always lock your car, even when parked in your driveway.
- Never leave your keys hidden in the auto--they can be found.
- Don't leave your purse or valuables in your car.
- Park in lighted areas and avoid parking in public lots for long periods of time.
- Properly used, an alarm system may prove an effective auto theft deterrent. It may also be worth purchasing a steering column locking device.
- Keep your garage locked and your car locked when it is parked at home.
- Don't leave the vehicle's title, credit cards, or checkbook in the glove box.

If you observe suspicious activity or person(s) around a vehicle, call the police immediately to report the location, description of vehicle, activity and person(s), and any other pertinent information for the police to investigate.

Vehicle Parking

A reminder to residents of some of our parking ordinances.

- No parking within 30 feet of a stop sign or traffic light;
- No parking on the fire hydrant side of any street or roadway within the City;
- No parking in marked Handicapped Parking spaces unless the vehicle is displaying a valid removable windshield placard or special license plates;
- No Overnight Parking of any vehicle on any street within the City between the hours of 3:00 a.m. and 6:00 a.m.
- No parking of any vehicle on certain designated and posted City streets when snow accumulation is two inches (2") or more.
- No parking or storing out-of-repair, dismantled or unlicensed motor vehicles on any property for more than 24 hours.

Landscaping Contractors' Permits Required

Permits are required for any person, firm or corporation conducting landscaping services in the City. Prior to the issuance of a permit, the applicant must furnish the make, model and serial number of any vehicles to be used, along with the name, address and telephone number of the owner and operator of such vehicles. Each applicant shall pay the sum of twenty-five dollars (\$25.00) for each permit which is in effect from January 1 to December 31 of each year. Prior to the issuing of any permit, each applicant is required to furnish proof of insurance. Applications for Landscaping Permits can be obtained, and permits are issued, at the Police Department.

The Federal Emergency Management Agency (FEMA) has completed the Flood Map Modernization Program. There have been several areas of the city that have been placed into the High Risk Flood zone (100 year flood plain). If your property has been placed into this Zone, you likely have received a letter from your lending company requiring you to secure flood insurance.

Flood insurance can be very costly. The City is in the process of gathering information to develop a policy on what can be done to assist our residences with this situation.

FEMA has developed a Preferred Risk Policy Eligibility Extension program. This program, if you qualify, helps property owners receive a two-year lower cost insurance. You may read more on this matter by visiting the FEMA web site at: www.FloodSmart.gov/PRPEExtension. The Building Department will also have copies of this program for you to pick up at our office. If you have any questions, please feel free to contact the Building Commissioner at 440-442-7403 or Assistant City Engineer Brian Mader at 216-731-6255.

Living in northeast Ohio, everyone is very familiar with SNOW. As I drive through the city, it has become apparent that snow plow operators are not adhering to our city ordinance on the placement of snow. It seems the majority are blocking the sidewalks. Please contact your snow plow company and remind them to push the snow away from the sidewalks and mailboxes.

Ordinance Changes - Over the past few months, there have been changes to several city ordinances as explained below.

Sign Ordinance - The ordinance has changed concerning the placement of construction signs. These signs are allowed but must conform to the following regulations. The sign can only be 6 square feet in area. The signs can only be placed in the yard during the construction period. Once construction is completed, the signs must be removed. No sign shall be placed in the city right of way or side yards of corner lots. Only one sign per residence is permitted.

Fence Ordinance - This ordinance has been changed to protect above ground pools and hot tubs. If you install a new pool this year, the following needs to be done. If the ladder is removable, it must be removed when the pool is not in use. If the pool comes with a permanent ladder, the ladder must be capable of being locked in the "up" position when not in use. If your above ground pool has a deck installed, then the ladder needs to be blocked or gated so no one can enter the pool area when the pool is not in use.

Spas and Hot Tubs - If your spa or hot tub is above ground, the cover needs to be secured so the cover cannot be easily removed when not in use.

House Address Display - Please remember to check your house address display. Make sure your address is visible from the street. The numbers should be 3-1/2 to 4 inches in height. This will make it easier for our safety forces to find your house in the case of an emergency.

The new construction season is approaching. When you start thinking of new projects, please call the building department to inquire about any permits that may be required. Permits are our only way of protecting the residents from unsafe construction and buildings. LETTER FROM SUPERINTENDENT DR. PHILLIP PRICE

MAYFIELD SCHOOLS LEVY CYCLE STRETCHED FROM THREE TO FOUR YEARS

Dear Resident,

This letter is to explain a recent decision made by the Mayfield Board of Education at their January 19, 2011 meeting. This decision, based on recommendations presented by the Superintendent and Treasurer, affects every homeowner in the district.

The policy of the Board with regard to requesting levies is to limit requests to once every three years whenever possible. Maintaining that policy has been extremely difficult given the state's recent fiscal situation and unfunded mandates that have cost Mayfield Schools millions of dollars a year.

Knowing that funds would be scarce, the district has imposed strict controls on spending over the past several years. Those decisions were often difficult because we did not want to compromise the excellent education our students receive. Your Board of Education has reduced the budget more than \$2.5 million over the past three years. Implementing our conservative spending plan, while sometimes painful, was the right thing to do. We have set priorities and stuck to them, as every family must in financially challenging times.

Today those reductions have allowed us to maintain a stable financial environment for our district. We are operating in a lean but responsible manner, focusing every possible dollar on classroom instruction, and requiring that every budget request be closely scrutinized.

We are pleased to report that as a result of this careful budgeting, the Board of Education will not request that an operating levy be placed on the ballot in the Spring of 2011 - even though this is the third year of the budget cycle. By extending the levy interval to four years, we believe it will be easier for families to budget and for seniors and others on fixed incomes to better cope with their property taxes.

Mayfield's two-year consecutive ranking of "Excellent With Distinction" on the Ohio Report Card stirred pride throughout the district and reinforced our theme of "A Tradition of Excellence." We enter 2011 realizing that there are enormous budget challenges on the horizon for all schools in Ohio. For now, however, we believe that stretching Mayfield Schools levy cycle to a fourth year is an appropriate and justifiable course.


